BY THE CADDO PARISH COMMISSION:

A RESOLUTION URGING THE CADDO PARISH INDUSTRIAL DEVELOPMENT BOARD TO REQUEST QUARTERLY FINANCIAL REPORTS FROM SHREVEPORT BUSINESS PARK AND TO PROVIDE THEM TO THE CADDO PARISH COMMISSION AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, the Caddo Parish Commission supports the Shreveport Business Park, a subsidy of Industrial Reality Group to provide jobs and businesses in the former General Motors facility; and

WHEREAS, the original agreement as stated in the contract between the Caddo Parish Industrial Board and Industrial Reality Group provides that quarterly financial reporting will be provided by Shreveport Business Park to the Caddo Parish Industrial Development Board when requested; and

WHEREAS, the Caddo Parish Commission urges the Caddo Parish Industrial Development Board to request from Industrial Reality Group every quarter a financial report; and

WHEREAS, the Caddo parish Commission urges that the report provided to the Caddo Parish Industrial Development Board be also provided to the Caddo Parish Commission.

NOW, THEREFORE, BE IT RESOLVED by the Caddo Parish Commission in due, regular and legal session convened, that the Caddo Parish Commission hereby urges the Caddo Parish Industrial Development Board to request quarterly financial reports from Shreveport Business Park pursuant to its lease agreement.

BE IT FURTHER RESOLVED that the Caddo Parish Commission urges the Caddo Parish Industrial Development Board to provide copies of said reports to the Caddo Parish Commission when received.

BE IT FURTHER RESOLVED that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that the Caddo Parish Commission Clerk is hereby instructed to immediately send an official copy of this resolution to the Industrial Reality Group and the Caddo Parish Industrial Development Board.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict herewith are hereby repealed.
